- PTP agrees to provide to the Client and the Client agrees to contract the following service: photobooth delivery & setup as well as takedown, unlimited photo strips during specified time, dvd of all photos taken and on-site attendant to aid in production of photos and memory book if ordered.
- PTP agrees to have the photobooth fully operational for a minimum of 80% during the period of operation specified below; occasionally, operations may need to be interrupted for service and/or photography optimizations.
- Accessibility for the photobooth delivery will be available at least 2 hours and preferably up to 4 hours before the event. Client will insure that venue will provide a table for any memory book needs and standard 120v electrical outlet(s) for photobooth operation.
- Reservations require a signed contract and \$200 deposit. This deposit is non-refundable but may be applied to a different event and date upon execution of a new contract and subject to availability, as determined in PTP's discretion.
- Contract balance is due one week before the contracted event. In the event Client cancels or fails to pay the balance of the contract price in full one week before the event, PTP is under no obligation to fulfill the terms of this contract and the downpayment is considered forfeited.

If partial performance has occurred, the client may accept the dvd (and memory book if ordered) upon agreement to pay a prorated amount of the original contracted price.
